Analysis of the Decree No. 41/2022 amending 02 Decrees on invoice and VAT deduction

The Decree No. 41/2022/ND-CP on amending and supplementing a number of articles of the Government's Decree No. 123/2020 on invoices and documents and the Government's Decree No. 15/2022 providing tax exemption and reduction policies under the Resolution No. 43/2022/QH15 is issued by the Government and takes effect on June 20, 2022.
